

FORESTRY CONSULTANTS RECOGNISED BY
NEW ZEALAND INSTITUTE OF FORESTERS (INC)

Consultants may be recognised by the N.Z. Institute of Foresters in two classes, Specialist and General. The appropriate criteria for inclusion in each class is given below (Constitution, para 40, (5) & (6))”

- “(5) A Recognised General Forestry Consultant must have completed a formal course of a standing recognised by Council in some branch of forestry, or an allied discipline. He must have completed at least five years’ field experience in general forestry since graduation or certification, at least two of which must have been in New Zealand, and have reached a position of responsibility recognised by the Committee, or to have made important contributions to forestry (as defined in Section X of the Constitution).”
- “(6) A Specialist Forestry Consultant must be recognised by Council as having adequate qualifications for his chosen field(s). He must have had at least five years’ experience in his chosen field(s) and have reached a position of responsibility recognised by the Committee, or have made important contributions within his chosen field(s).”
